Minutes for 1 March 2017 – 6:30 to 8:40

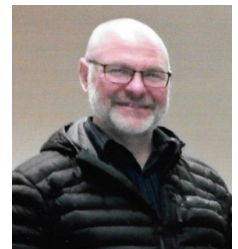

2. Approval of Minutes from February 1, 2017. Bill/Jim/approved. Many current issues were noted. Minute-taker appointed: Ellen.

3. Federal Heritage Project to nominate a Surrey National Historic Site - The Arboretum and

Inaugural Plantations were recommended. Don, Amar and Grant to prepare application forms (online instructions provided), and get letters of support from other heritage groups (eg. Michael for SHS). No deadline date.

a) SNAP Coordinator Winter Update - Nathan Ross reports: Jan 10 - SNAP Partnership Mtng at SNC, and Feb Nathan gave SNAP History to White Rock Group. (They have speakers which bring in members). Nathan and Parks Staff (Billie Jo, Ken Crosby, Leah Zia, Cam Bennett) reviewed 558 applications from UBC, Kwantlen and SFU - and interviewed 30! Exams are in April, Plan to hire Leaders May 8, 15 workers altogether. City (Neal Aven) will draw up contracts soon. Need to purchase TShirts (3 each), Canopy, Table Covers, Caps, Vehicle

Signs. Needs \$500 in Petty Cash - cheque tonight.

b) Financial Report - Jim Foulkes reports: VanCity SNAP Balance - \$27000; Prospera GT Account Balance - \$16700; Gaming Account Balance - \$424. Year 2015/16 Finances completed with required reports submitted, taking many hours. 2016 SNAP - 4 Vehicles - Lease Costs \$21,200, Insurance \$8000, \$2250 fuel.

Total GST paid - \$1400. (50% rebate coming). Thanks, Jim, for all this detailed recording.
