Letter to Robin Landucci July 5.

Rob was on vacation and replied July 30. He'll respond in 7-10 days. The content of the letter is below:

1) the Environmental Sensitive Area

The Southeast corner of GT is labeled as an environmental sensitive area. It's not clear to me how much this includes. I think it was originally a rectangle bounded by the hydro right-of-way to the north, 144th and 148th to the West and East, and 92nd on the South. On the City's brochure it's a triangle, bounded by Fraser Highway, 92nd Street and 144th Street. *How do we find out what area is the ESA? Is there a document describing what that means?*

In previous conversations with Neal Aven (probably about a year ago) there was some discussion of doing an assessment of what's actually in that area. As I recall (with my sometimes faulty memory) Neal thought it should be fairly easy to do, and worth exploring. *Has anything happened with this? How can we help get the ball moving on this sort of project?*

2) Trail assessment and planning in Green Timbers

This is another left-over from a few previous conversations with Neal. The widening of 100th Avenue and the planning widening of 148th have opened up discussions with the road guys about multi-use pathways, and trails too. The new trail from 100th and 140th to the parking lot is part of that.

We think we should take a big-picture look at what we want to achieve with trails through Green Timbers, and how we can encourage people to go for walks of different lengths and types, and from different access points.

We're thinking we might even be able to take advantage of the road guys' works-in-process to enhance usability of the forest. *Would you be interested in exploring some of our thoughts and ideas on the subject?*

3) All-weatherizing trails

Obviously there are different types of trails through GT, and I personally find even the most rustic of them to be passable during the wettest months of the year. Some of our members did have a few concerns about boggy bits being expanded by walkers as they trod on the trail edges to avoid puddles, etc. You can see previous efforts to ameliorate this with cordwood near King Creek (apparently a heritage society initiative from 30 years ago).

We thought we should ask your opinion, and perhaps you or the trails team have techniques and methods to move water along, while still preserving the rustic nature of the trails. *Is this something worth exploring further?*

4) Edge effects from development

We're not sure if we should be concerned about edge effects from the planned widening of 148 Street. I know the specs are careful and well-thought out, but a member pointed out that after the subdivision went in next to Bose park a number of trees next to the road died. This would have been in 2015 to 2016 at the 62 Ave curve just north of 164 Street. *Are you familiar with this at all? Are we being overly concerned?*

Report harvesting in parks

We've noticed an increase in reports of people harvesting vegetation in our parks – most recently in Sunnyside Acres Urban Forest. The harvesting of vegetation in Surrey parks is prohibited by bylaw 13480, including berries, conks, mushrooms, fiddleheads and moss. Removing vegetation reduces food sources for wildlife, and walking off trail can lead to soil compaction, trampling of vegetation, and erosion in our sensitive urban natural areas.

You can help by reporting any incidents of people harvesting vegetation from Surrey parks to 604-501-5050.

COLUMN: Pressures of change on longtime Surrey residents (August 22, 2018)

The ever-changing landscape along Fraser Highway is a microcosm of the change underway in almost all parts of Surrey.

By the 1970s, there were few signs of agriculture on the street, except in the lowlands near Fry's Corner. Some of the most significant growing still taking place was at the Green Timbers forest nursery near 140 Street.

The nursery and plantation on both sides of the street was part of a commitment made by the province in the late 1920s, after the original Green Timbers first-growth forest was cut down.

The city began a program to four-lane the road across Surrey in the 1990s, with the notable exception of the portion within the Green Timbers forest.

Good morning, I hope this email finds you all well. There has been a lot of talk about the Inaugural Plantation sign (which is great!) and I have attached an updated copy of the new design with marked-up edits that Ellen and I discussed earlier this week.

Don, I started this process in April (see below) and it was a huge oversight not to involve you - I am really very sorry.

I have been working with my design group to refresh the sign, with content staying very similar to the two signs I have combined. It will be printed on aluminum (36" x 18") and installed on two rough-cut cedar posts as per the City standards. The sign will be placed near where the current sign is, but closer to the edge of the trail so that people can easily read it.

This site is steeped in history and I don't want to ever lose sight of why we have the forest, the park and the nature centre (and the people behind this - past and present) - I hope this sign conveys that.

Subject: Stand up for Protected Places in Canada!

** The Protected Places Declaration
A Natural Legacy

We have a generational opportunity to protect the biologically diverse areas that we have grown up loving. Consider adding your voice to the movement towards protecting our land and waters by signing this declaration.

Planet Earth is a shared home for humankind and millions of other species and our fates and well-being are interdependent. Recognizing our responsibility to the whole, we, the Signatories, urge governments, civil society and business leaders across Canada to:

- * Develop, initiate and invest in action plans to protect at least 17 percent of our lands and inland waters and 10 percent of our coastal and marine areas by 2020;
- * Ensure that these action plans are designed and implemented to achieve ecologically representative, well-connected protected areas networks in every province and territory, based on both Indigenous knowledge systems and science; and
- * Ensure protected areas identification and management decisions respect the right of Indigenous Peoples to free, prior and informed consent.

We have signed this declaration:

Because a mass extinction unlike any since the disappearance of the dinosaurs 65 million years ago has already resulted in global wildlife populations decreasing by over half since the 1970s;

Because protected areas directly address the primary driver of extinction, habitat loss and degradation;

Because a sustainable and equitable future requires that we address this threat and protect natural areas of sufficient size, diversity and number so that all life in Earth may continue and thrive;

Because international agreements, including the United Nations Declaration on the Rights of Indigenous Peoples, the Convention on Biological Diversity, and the United Nations Framework Convention on Climate Change recognize the rights of Indigenous Peoples, including the right to free, prior and informed consent;

Because protected areas established and managed by or in cooperation with Indigenous Peoples can serve to sustain and strengthen Indigenous knowledge and value systems and cultural practices;

Because Canada signed the 1992 UN Convention on Biological Diversity, an international treaty that aims to conserve the diversity of life on Earth and ensure that its resources are sustainably and equitably shared by all;

Because Canada and the other signatory countries to the Convention adopted the 2010 Aichi Biodiversity Targets, which include Targets 11 and 18;

Target 11: By 2020, at least 17 percent of terrestrial and inland water areas, and 10 percent of coastal and marine areas, especially areas of particular importance for biodiversity and ecosystem services, are conserved through effectively and equitably managed, ecologically representative and well connected systems of protected areas and other effective area-based conservation measures, and integrated into the wider landscapes and seascapes;

Target 18: By 2020, the traditional knowledge, innovations and practices of indigenous and local communities relevant for the conservation and sustainable use of biodiversity, and their customary use of biological resources, are respected, subject to national legislation and relevant international obligations, and fully integrated and reflected in the implementation of the Convention with the full and effective participation of indigenous and local communities, at all relevant levels.

Because all of Canada's federal, provincial and territorial Ministers of Environment, Parks and Wildlife signed A Statement of Commitment to Complete Canada's Networks of Protected Areas in 1992, and this work remains unfinished;

Because Canada has ample opportunity to protect natural areas and meet the Aichi targets given the country's vast size and relatively small human population;

Because it is in our collective interest to maintain the many ecological, social, cultural, health and economic benefits that are derived from natural areas, including clean air, clean water, wild foods, genetic resources, nature-based development opportunities, and much more.

Our common future and the health of the planet depend on protected places.
