May 1st, 2020

Amy Kim, Program Coordinator

Past Month:

- Contingency planning for 2020 season continues
- Find projects for Amy to work on if the season is delayed
- Procurement of equipment and supplies for 2020 season

This Month:

- Started Urban Forest Awareness project that seeks to connect Surrey's three designated urban forests (GTUF, SSAUF, Fleetwood). Through this project, I am looking at the old GTUF booklet/nature guide.
- Canada Summer Jobs sent an email with questions to answer regarding any potential modifications required in order to run SNAP. Colleen and I are working on those responses as they are due next week.
- We are working with City staff to come up with potential team structures. One potential structure we've identified is to have teams of 2 (1 team leader and 1 team member). Rather than have Habitat Restoration and Tree Care as separate teams, we're exploring the idea of having a 'hybrid field-based team' (ie. merging HR and TC). We would have 3 field-based team leaders with 3 field-based team members, and 2 outreach team leaders with 2 outreach team members. Through this team structure, we can offer 10 positions in the summer. Additionally, we are thinking of having a fall season. We could offer 6 field-based positions to help Natural Areas with plantings to make up for the reduced number of positions in the summer and space out the number of people working to make physical distancing easier. However, we have not been given direction from senior management yet.

Refinement to Sensitive Ecosystem Development Permit Guidelines

Surrey's Sensitive Ecosystem Development Permit Guidelines were adopted by Council in 2016 and have been effective in managing riparian areas and Green Infrastructure Protection. Guidelines and application procedures have been adjusted over the past few years to ensure the application process remains valid and effective.

One minor adjustment is proposed to the Sensitive Ecosystem Development Permit Guidelines. The amendment proposes to combine the overall site requirements for both the Streamside Protection Areas and Green Infrastructure in order to provide consistency between the two categories. These proposed amendments are outlined in Appendix "I".

I am writing to file my written delegation during the Virtual RCPH set for April 20th, 2020 at 7:00pm
Agenda Item 5 page 3:

5. ""Surrey Official Community Plan Bylaw, 2013, No. 18020, Text Amendment Bylaw, 2020, No. 20008""

PURPOSE: To amend ""Surrey Official Community Plan Bylaw, 2013, No. 18020,"" as amended, to address recent changes to the:

1. BC Building Code regarding universal access improvements for parking;
2. More clarity for sensitive ecosystem application processes; and
3. Minor map amendments to update the Employment Areas map with respect to previously approved rezoning applications.

These amendments are described and outlined in Corporate Report 2020-R061.

RECOMMENDATION:

I propose Council consider suspending further action in regard to this item on the basis that the CR 2020-R061 is completely inadequate in providing Council with the full ramifications of this textual amendment, with particular reference to Appendix II Map, the area circled around Green Timbers Way & 140th Street. As generally described in my supporting reasons and citations.

GENERAL COMMENT:

The Corporate Report 2020-R061 lack information, detail and is generally lacking in transparency in regards to the proposed text amendments, which do not address the issues that encompass the DVP 7916-0013-00 city owned property site LOTS 9900 Bio Fuel Plant, from COSMOS: (OCP Text Amendment to allow a higher density in the Multiple Residential designation; OCP Amendment from Mixed Employment to Multiple Residential and Rezoning from RA to CD (based upon RMC-135 and RMS-2) to accommodate future institutional, residential, office and civic uses including care facility, emergency shelter/transitional housing, offices and bio-energy facility.

For specifics, please turn to page 5 of the CR under CURRENT PROPOSAL, quote: The City has identified the subject site as a possible location for a bio-energy facility, which in this case, proposes to use clean waste wood to produce heat for its district energy services.

Surrey road survey says 92.9% of respondents drove own vehicle to work, only 1.8% walk

SBOT says 'all major' infrastructure projects should be planned 'well in advance of increased demand'

LAUREN COLLINS, Feb. 7, 2020

In the survey, 92.9 per cent of respondents said they drove their own vehicle to work. That's up from 81.3 per cent in 2018 and 87.1% in 2016, but it's comparable to 92.6 per cent in 2017.

With that, only 1.8 per cent of respondents said they walked to work, which is down from 4.4 per cent in 2018.

Fifty-three per cent of respondents live and work in Surrey, which has "remained comparable to all levels since 2016." However, 23.5 per cent work in Surrey, but live south of the Fraser. That's comparable to data since 2016.

According to the survey, the top three corridors requiring attention are: arterial widening to five lanes on Fraser Highway between Whalley Boulevard, including through Green Timbers (52.2 per cent); South Surrey/Highway 99 interchanges at 24th, 32nd and 152nd Avenues (53.9 per cent); and widening 152nd street between 40th and 50th avenues (43.5 per cent).

Here's another initiative to see and record wildlife:

The City Nature Challenge is a global initiative to observe and record as many plants and animals as possible in just four days.

Participation is easy - all you need is a smartphone, or a camera and a computer.

Download the free iNaturalist app or visit www.iNaturalist.ca and make a profile. Then, join the "City Nature Challenge 2020: Surrey BC" project. Between Friday, April 24 and Monday, April 27, get your nature nerd on and share what you can see in your yard, neighbourhood, or from your balcony.

After the challenge, the photos you post on iNaturalist will be reviewed by the City's professional biologists. This data will help us to understand and better manage biodiversity in Surrey.
